1 About this document

1.1 Function

This operating instructions manual provides all the information you need for mounting, connection and setup as well as important instructions for maintenance, fault rectification, the exchange of parts and the safety of the user. Please read this information before putting the instrument into operation and keep this manual accessible in the immediate vicinity of the device.

2.1 Authorised personnel

All operations described in this documentation must be carried out only by trained specialist personnel authorised by the plant operator.

The components described in this manual are replacement components for existing sensors.

2.3 Approvals

If the instrument comes with approvals, the associated approval documents of the sensor must always be noted. They are included with the delivery but can also be downloaded under "www.vega.com", "Instrument search" as well as via "Downloads" and "Approvals".

3 Product description

3.1 Configuration

Scope of this operating instructions manual

This operating instructions manual applies to electronics modules in instruments with the following hardware and software versions:

PLICSMOBILE 80 series (hardware ≥ 1.0.0, software ≥ 1.1.0)

Scope of delivery

The scope of delivery encompasses:

- Electronics module
- Documentation
 - This operating instructions manual
 - Ex-specific "Safety instructions" (with Ex versions)
 - If necessary, further certificates

3.2 Principle of operation

Application area

The electronics module is suitable for exchange in instruments of the PLICSMOBILE 80 series. You can find information of the available versions in chapter "Mounting preparations".

3.3 Packaging, transport and storage

Packaging

Your instrument was protected by packaging during transport. Its capacity to handle normal loads during transport is assured by a test based on ISO 4180.

The packaging of standard instruments consists of environment-friendly, recyclable cardboard. For special versions, PE foam or PE foil is also used. Dispose of the packaging material via specialised recycling companies.

Transport

Transport must be carried out in due consideration of the notes on the transport packaging. Nonobservance of these instructions can cause damage to the device.

Transport inspection

The delivery must be checked for completeness and possible transit damage immediately at receipt. Ascertained transit damage or concealed defects must be appropriately dealt with.

Storage

Up to the time of installation, the packages must be left closed and stored according to the orientation and storage markings on the

Unless otherwise indicated, the packages must be stored only under the following conditions:

- Not in the open
- Drv and dust free
- Not exposed to corrosive media
- Protected against solar radiation
- Avoiding mechanical shock and vibration

4 Mounting

4.1 General instructions

Safety during mounting

We recommended installing the replacement electronics with the instrument dismounted and brought to a suitable place, e.g. a workshop. If it is not possible to dismount the instrument, the electronics module can also be installed on site at the measuring point.



Warning:

Switch off voltage supply before starting the installation procedure. The replacement electronics may only be installed when the sensor is in a **de-energised state**. Non-observance will damage the electronics!

Ex approval

It is absolutely necessary that the following points are observed with instruments with Ex approval:



For instruments with Ex approval, make sure that the replacement electronics module has the same designation as the exchanged electronics module.

4.2 Mounting preparations

Assignment

The electronics modules are mounted into the electronics compartment and are adapted to the respective instrument. Make sure that you are using a replacement electronics suitable for the instrument.

The electronics modules differ:

Ex and non-Ex

4.3 Installation procedure

Proceed as follows:

- 1. Switch off power supply
- 2. Unscrew the lid of the electronics compartment






Fig. 1: Remove connection cables and loosen the holding screws

- 1 SIM card
- 2 Connection terminals
- 3 Antenna cable
- 4 Screws (2 pcs.)
- 5 Dismounting tool
- 3. Remove the SIM card applying slight pressure to the card slot
- Lift the opening levers of the connection terminals with a screwdriver
- 5. Pull the wire ends of the connection cable out of the cables
- Loosen the two holding screws with a screwdriver (Torx size T 10 or slotted screwdriver size 4)
- Note: Detach antenna cable carefully in the direction of the screw base
- 8. Pull the previous electronics out with the dismounting tool.
- 9. Insert the new electronics module carefully.
- 10. Screw in the two holding screws and tighten them
- 11. Connect the wire ends of the connection cable according to the operating instructions manual of the respective instrument
- 12. Insert the antenna cable again
- 13. Insert the SIM card according to the operating instructions manual of the respective instrument
- 14. Screw the housing lid back on

The electronics exchange is now finished.



As a rule, an exchange of electronics must be documented internally if Ex applications are involved.



5 Setup

5.1 Setup preparations

With instrument serial number

If you ordered the electronics module **by stating the instrument serial number**, it is ready for the setup procedure immediately after installation and connection to power supply.

Without instrument serial number

If you ordered the electronics module **without stating the instrument serial number** or you are using a suitable electronics module from stock, you first have to load the instrument data after the installation.

The instrument data contain the serial number and the instrument version.

At <u>www.vega.com</u> go to "Instrument search (serial number)". The order data of the instrument are displayed after entering the serial number.

Below the order data you will find "Sensor data for Service DTM" as an XML file. Save this file with "Save as" on your PC and transfer it via PACTware and the Service DTM to the instrument.

Note:

Each electronics module is supplied with new access codes (Bluetooth/network/emergency access code). The previous access codes cannot be taken over/further used after an electronics exchange.

While accessing via DTM, the access codes must be thus entered once new. With a VEGA Inventory System connection also the network access code must be updated in the VEGA Inventory System. For this, you have to contact your responsible contact person.

5.2 Setup steps

Parameter adjustment

If the instrument is used in the same application after the electronics exchange, the previous parameter settings of the instrument must be restored. To do this, you can use the import function of the adjustment software PACTware with the respective device DTM.



6 Dismount

6.1 Dismounting steps



Warning:

Before dismounting, be aware of dangerous process conditions such as e.g. pressure in the vessel or pipeline, high temperatures, corrosive or toxic products etc.

Take note of chapters "Mounting" and "Connecting to power supply" and carry out the listed steps in reverse order.

6.2 Disposal

The instrument consists of materials which can be recycled by specialised recycling companies. We use recyclable materials and have designed the electronics to be easily separable.

Correct disposal avoids negative effects on humans and the environment and ensures recycling of useful raw materials.

If you have no way to dispose of the old instrument properly, please contact us concerning return and disposal.
